The Helpline Quiz

- 1. You are on shift as a Helpline volunteer. You receive a call from a member of Narcotics Anonymous who tells you that their doctor has prescribed them medication that is a narcotic, and they ask you if this is okay. You should:
 - a. Tell them "Yes, it's okay."
 - b. Tell them to call their sponsor and read the "In Times of Illness" NA publication.
 - c. Tell them to call their doctor.

- 2. You receive a call from a person who wants to make their friend stop using. You should:
