Report:

In March the prudent reserve was at \$42.41 and in March I ordered 100 paper card-stock key tags (from the MSO) for the H&I subcommittee at a cost of \$40.47. At the 7/12/20 P&A meeting I plan to give the receipt for this expense to the treasurer along with \$1.94 cash to zero out the prudent reserve for the literature subcommittee. At this time I will NOT ask for reimbursement.

Most of our literature is locked in the church and is not accessible but the supplies that were received from our most recent WSO order are still in my possession, along with all of the tokens owned by the ASC. I was recently contacted by a member seeking tokens for a home group. Our current guidelines do not provide for literature sales outside of the ASC meeting, and changing this would require changing the guidelines and sending it back to the groups (if we follow our guidelines.....).

I lost most of my personal stock of used books in the May floods (along with the Saginaw Bay Area historic archives), and in the recent months the market supplies of used books have been greatly reduced. Used book prices have increased as a result.

I will likely NOT be at a face-to-face ASC meeting next week if one is held.
