Dinosaur Days is the biggest MRCNA fundraiser event. We are still taking donations for our silent auction. We are to conduct a MRSCNA Meeting Schedule Survey and decide meeting modality for remainder of 2025 before our June regional meeting. Discussion is as follows: In favor of meeting in-person: -Technology and meeting via Zoom can be challenging for some committee members. -Meeting in person allows us to host events and discussion topics night before, including Public Relations webinar presentations, and/or RD & AD could host a service panel. -We are able to support newer Areas when we host the Regional meeting in their Area, but possibly consider Area's willingness/ability to host. In addition -We could possibly reduce our meeting frequency to quarterly and only meet in person (but always have hybrid options available). -Human interaction during in person meetings is important.

In favor of meeting virtually: -Meeting in person is contingent upon an Area's financial standing and ability to pay for an RCM/RCMAs travel expenses (some Areas may not be able to afford subsidizing in person meetings). -Meeting in person is also dependent upon our Region's financial health, and ability to pay our bills first before funding in person meetings, so perhaps we need to meet virtually until our finances are better. *Survey questions are listed below in the announcements section at the end of these minutes*. Conclusion: Survey will be taken back to Areas for discussion and voted on at the June Regional meeting. We were reminded to be prepared to provide your first and second choice options for in person vs online meetings at the June 1, 2025 virtual Regional meeting.
