RETREAT: Hello, The Retreat for 2026 had our first committee meeting on August 19, 2025. There were 11 interested NA members in attendance, some long-time members and a few newer members. We basically went over the service positions that would need to be filled, some of the recommended duties and responsibilities for each position. Then we went over the goals for this year's Retreat. The first was to have the Registration and Shirt Flyers out for AREA's November meeting, November 16, 2025. Next our agenda was to establish what activities would need to be done to realistically raise funds for the 2026 Retreat Scholarship fund. Based on past experience and fundraisers we believe that putting on the St. Patrick's Day dance on March 14, 2026, "Passing the Hat" funds from the 2025 Retreat, the "Single Occupancy" funds and private individual NA members donations would be more than adequate to support the scholarship fund for the 2026 Retreat.
