# CHAIRPERSON/POLICY AND ADMINISTRATION:

- The NAW\$ literature prices are going up 16% on January 1st, 2026. When should we raise the prices here at area? The literature currently in the cabinet has been purchased under the old prices.
  - On January 1st, 2026 we will make the pricing changes. All orders made after January 1st, 2026 will be placed under the new prices.
  - The new prices are on www.na.org
- One person speaks at a time, to the whole group, respect each other. This is not a shouting match.
- Newcomer Event excess funds:
  - After three years of information, it has been suggested that the NCE raise their prudent reserve.
  - o Every sub-committee is accountable to area.
  - At the end of each year to allow all funds to be handed over to the area treasurer. Then when needed all the funds will all be given back.
    - The retreat does not need to return funds.
  - This will all need to be sent back to the groups. Our guidelines are not clear on this topic.

RCM: December 7th on Zoom is the next Regional Meeting

MRCNA turned over ~\$15k to the regional treasurer as profit from the convention, and the treasury balance is now > \$26k. ~14% was sent to NAW\$. The Conference Agenda Report (CAR) should be available online on November 3<sup>rd</sup>. In February there will be a meeting in the Midwest Zonal Forum in Minnesota. NA.org has information and suggestions for facilitating ZOOM meetings for those that are interested. In August the phone line had 75 calls with 23 live calls. MRCNA meetings for October through March will be hybrid from Jacobs Well in Traverse City. MSO rep is still an open position. An OWL device was purchased for the Regional meetings but has not yet been tested. Once it has been verified as functional a decision will be made on what to do with the old hardware. Much discussion occurred about the location/rotation for the regional meetings (ie, where to go next; previously scheduled area or move to next location on list). - <u>Vote #1</u>, guideline change proposal. To remove "and on zoom". Section I,3 of the guidelines currently states The ASC shall meet in person and on zoom.
  - Can we remove "and on zoom." from the Area guidelines? GSR's voted "YES"
- <u>Vote #2</u>, guideline change proposal, Section XI. 7. Currently the Newcomer Event is required to vote in their new chair in August with the other sub-committees.
  - Can we add a line to the Newcomer event section of the guidelines "Newcomer Event will elect a new chair at Area following the Newcomer Event"? GSR's voted <u>"YES"</u>

#### **NEW BUSINESS:**

New Comer Event guideline change proposal. After much discussion and having the entire Newcomer Event Committee in attendance, here is a proposed guideline change. Feel free to discuss it with your homegroups. There is no need for a vote at this time. P & A and Area will discuss it at the November 16th, 2025 meeting. Following that discussion there will be a completed guideline change proposal for groups to vote on.

<u>Proposed Guideline Changes for Newcomer Event Subcommittee</u> (This would replace the current guidelines)

- A. This committee will consist of a chair, co-chair, and a secretary (co-chair and secretary dependent on willingness). Also, any NA member who wishes to carry the message of recovery through service-work.
- B. The primary purpose of this committee is to plan and hold an annual, day-long mini convention where members share experience, strength and hope, and spread an NA message to newcomers.
- C. The secondary purpose of this committee is to raise funds for the newcomer event by hosting NA-related fundraisers throughout the year.
- D. Upon completion of all financial obligations, any leftover funds will be allocated in the following manner:
  - Expenses for the subsequent year's event, which are variable depending on venue and miscellaneous costs for the event (I.e. literature, supplies to be used at event, lunch cost, etc.)
     This expense will be equivalent to the cost of the previous year's event.
  - b) \$400 set aside to host the fundraisers necessary to hold the annual event and for other operating expenses.
  - c) Any excess funds will be set aside and held by the committee chair to be used for extra literature or supplies relevant to carrying the message to the newcomer.
- E. While the committee may choose to donate funds directly to the SBASCNA, it has no responsibility to do so. Its responsibility lies in using the funds appropriately to host the annual event and to carry the message.
- F. In the case of a dissolution of this committee, any funds held by the committee will be given to the area treasurer for area to use as it sees fit.
- G. The duties of the chair will include:
  - a) Scheduling and chairing monthly subcommittee meetings, in which other service positions will be discussed and voted upon.
  - b) Providing a monthly, itemized account of the committee's funds and the expenses of its fundraisers as well as the annual event.
  - c) Keeping close communication with surrounding ASC's, Area Subcommittees and Groups to help avoid scheduling conflicting events when possible.
