## **Old Business:**

- MRCNA BID: This area working on bids for MRCNA to be held in our area. Katy G created a Facebook group and all in the group qualifies for what we need to submit a bid. The bid needs to be put in place by April. **(TABLE)**
- AD/Hoc workshop: Jim C. contacted Sally S. and they have been discussing it and having an idea of combining it with service. How to be of service. They would be combining this with the workshop. This may be happening May 18<sup>th</sup>. There was talk about this event doesn't need to be an Ad/Hoc event rather have it as an Area workshop. More information will be revealed.

  (Melissa brought up an old event "Being of Service" workshop and a document created for how to be of service.) (TABLE)
- Meghan filled out the Tax exempt for Gordan's Foods and there were two address's at Gordan Foods. The kid at Gordan foods stated he would be giving the info to his manager. (Resolved)
- Parking for the Bayshore race: It was denied. One group said yes and two stated no.

## **New Business:**

- Region: In August the Region meeting will be in our area. Rob wanted to talk to see if Jacobs Well would be available but with it being a Sunday there is the concern of parking with the church. An idea was possibly switching the dates that we would host due to it being the same weekend as NWACNA. It was stated that the meeting could be held at NWACNA and they could either camp out or rent a room at the motel in Mesick. Rob and Zach will be doing some research to see what would be best. (Tabled)
- Region donation: It was stated that we did not do a donation for the last Region donation. Jim C asked the question if our Area ever thought about donating a percentage of what our Area brings in. Jen S. stated that a few years ago our Area was concerned what Region was doing with the funds so we at that time did not want to donate a percentage to Region. We typically donate from \$150 to \$300.

If we were to donate by average, would we donate the average of just the 7<sup>th</sup> or would we put in the fundraiser's funds within that percentage as well?

Melissa W. stated that it would be nice to keep it flexible instead of trying to figure a percentage and stick to that each month.

It was also stated that WSO is struggling with funds. WSO pays for interpreters to update our literature and so many other things.

There was as well a suggestion to send the funds directly to WSO but what Area decided to do is donate \$500 to WSO and \$600 to Region. **(Resolved)** 

- Cleaning supplies for Jacobs Well: For the supplies that they are needing, thinking about
   \$75 would be needed. This was approved. (Resolved)
- Literature guidelines regarding literature donation to groups in need of literature supplies: Jen stated she looked into this and stated that we may need a running inventory of what we have.
   Jim C. stated the Area guidelines say that any budget request would need to go through Area since Literature does not have their own treasury. For today's Literature donation, Area stated that we would have Jen S. put it in her report the donation for Kalkaska's meeting this month. Jen will be working on Literature guidelines. (Tabled)
- Sally S. suggested to put a section (bring back to groups) so that way the GSR's can read the minutes. I will put a section each minutes for this. The secretary has added this section on the bottom of the Minutes and will continue to have this located at the bottom of the Minutes moving forward. **(Resolved)**
- For literature orders, we talked about the differences when we order through MSO or World. Jen S. stated that World gives us a discount. Zach W. brought up that we have looked into this before, and MSO isnt "NA" but supports NA. Sally S. brought up the other reason why we started going through World was when MSO was not using the funds correctly. They were not paying the bills. MSO is still struggling with funds, and it may not make sense to go back to them when what we are doing with World works. Jen S is going to do some research with how many Areas are ordering from the MSO. (Tabled)
- Tim brough up Social Media post. Stated that there are certain fellowship pages for NA that are not a hidden channel on Facebook. Anyone can search that page and view what is on there. Just wanted to bring this up for others who may be concerned about anonymity. To make sure if they are posting information on said pages, to make sure it is a private and hidden page or ask for approval to have something posted that would involve names or pictures. Keeping anonymity in mind. (**Resolved**)

- I brought up if I should put a section for next meetings old business and we are going to just have the secretary just either put "Tabled" or "Resolved" at the end of each topic brought up in New Business. (**Resolved**)
