As always there are big beautiful things happening in Public Relations this month!

We have hammered out the details for our upcoming PR Workshop event being held this coming Saturday November 22, 2025 in Irons Michigan! The event is scheduled from 2pm-5pm at the Irons Union Church. We will be starting the event with the potluck style meal followed by PR info/brainstorming tables and ending with two lead speakers. PR will be providing the main entrée but all attendees are encouraged to bring a dish or snack to pass. I have brought flyers for all GSR's to take back to their groups but please announce this event at all meetings as its coming up quickly! Let's show Irons that PR and the fellowship supports every corner of our vast NWM Area! This is a free event!

We have been working hard on re-connecting and re-building relationships with many of the jail professionals in our area recently. I am excited to announce that we have recently started taking an NA meeting into the Mason County Jail! We have also been hearing from many important sources in the community that the Grand Traverse County Jail is FINALLY interested in allowing NA and other fellowships to restart recovery meetings in their facility. To be honest have been sneaking NA Basic Texts into the facility in a roundabout way but we all know that's not the same as attending an in-person meeting, especially for those who are incarcerated. As some of you may know we had been taking meetings into that facility for many years prior to Covid. Since the pandemic we have been trying to get back in with no avail. It sounds like hopefully that is about to change! Which means we will need trusted servants willing to get clearance through the jail by attending a short facility training to meet the facilities requirements and by meeting the requirements for this trusted servant position set by the PR guidelines. PR requires volunteers for this position to have at least 1 year clean to chair, at least 90 days to co-chair, are able to communicate a clear NA message, adhere to the "Do's and Don'ts" of PR Service and

willing to review the information and guidance included in the H&I Basics booklet. If interested please let me know or contact our Corrections Facilities Coordinator Yon K. directly.

We have also finally been given the go-ahead to install the NA little library at Jubilee House! The facility already has a 4x4 post affixed into the ground so we can just install the library on top at our convenience! I have submitted an order for Literature today paid for with previously allotted funds from Area so as soon as we get all of it received from the next Literature order from NAWS we will be ready to go!

We have run out of October-December 2025 meeting schedules quickly this quarter so 100 more have been ordered to print to get us through the end of December. When they're done Sally is going to pick them up and refill the schedule box on the gray shelf here at the Well.

As I've mentioned in the past, we have a PR liaison group lovingly referred to as "PR South" working in tandem with the PR Subcommittee to ensure that PR efforts are being met towards the Manistee corner of our Area. They are holding a monthly "PR South" business meeting every last Wednesday of the month at 8pm which immediately follows the New Attitudes Meeting at the First Congressional Church in Manistee. This PR South meeting will soon be going hybrid using the Area Zoom account. When hybrid is implemented and active this information will be added to the Area website so that anyone interested in attending can do it without the travel!

I do not have money to turn in this month to the Area from our November 2025 PR Open Talk Meeting. Our 7th Tradition collected was \$9.00. This money went to paying our rent for the space to Recovery First. We had a total of 29 people attend the meeting. This is one of only a very few meetings in our Area that hosts a speaker monthly so come hear some ESH every first Sunday of the month at 7pm at Jacobs Well!

I do have a few budget requests this month for the following things:
