#### **Treasure Report:**

Hello Fellows!

I'm officially on the bank account and received access to the online banking. There weren't clear records since August area, so I went through the bank account information as well as the area minutes and balanced the "books" to make sure this month was accurate and up to date. I'm happy to say when I got to this month everything looked in order. I will be asking for an adjustment in past area minutes and will reflect that information later in my report. We couldn't locate the P.O Box key, so Zach got one from the Post Office and copies made which cost \$34.00. Zach W. paid and gave me a receipt of purchase and will be requesting reimbursement at this area meeting and will be reflected in my report next month. The bill for the liability insurance came in the beginning of the month and needed to be paid by the  $22^{nd}$  of this month so I paid that and is included in this report.

Area had a starting balance of \$3,509.56. Income from groups of \$131.25. Income transfer of \$1,796 received from Activities from proceeds from the Halloween dance. Expenses of \$1,630.34 which consisted of \$115-Rent payment to Faith Reform Church Region Donation-\$300. Reimbursement to the RCM: \$205, Liability insurance: \$383, Transfer to literature of \$100 for I.Ps requested by Public Relations. Copy Shop: \$31.50, Public Relations

poster drive: \$300, Public Relations speaker Jam: \$150, and finally a reimbursement to

Activities Chair Jared: \$45.84

When Pete was treasurer, he created buckets within our bank account when area funds got put directly back into main account it added a penny to the total so including that our ending balance is \$3806.48.

Activities had a starting balance of \$95, income of \$2101, expenses with a transfer into the area balance in the amount of \$1796, Activities balance is \$400.

Retreat had a starting balance of \$2,000, income of \$105, income from Venmo with the ending balance of \$2145.

Literature had a starting balance of \$559.08, income of \$502.25, income from Venmo of \$13, income from transfer of \$100, Expenses of \$671.98, with the ending balance of \$502.35.

When balancing past months and looking at the area minutes, the money coming in and going out I noticed inaccuracies in the Treasurer reports. Starting back in September total expenses should be \$570.03, including a \$225 transfer to activities with an ending balance of \$263.13. Retreat had total expenses of \$4940.61 with an ending balance of \$5231.43.

October's minutes the starting balance should reflect the previous month's ending balance which didn't. So, the starting balance should be \$263.13 and the ending balance of \$348.13. Retreat's starting balance should be \$5,231.43 with the ending balance of \$5231.43. The money the area received from the retreat is \$3,281.43.

The sixth Michigan Regional Guideline Update Ad hoc Committee Meeting was held on December 10, 2023, at 9:00am via Zoom. The next Guideline Update Ad hoc Committee meeting is scheduled for Sunday, January 14, 2024, at 9am.

PR is going to buy 10 books for each of the 26 DOC prisons in the state of Michigan at a cost of \$3900.00.

It was agreed budgets will be submitted in August then approved in October going forward so there's time to review them before they are approved.

The MSO rep was given a list of questions and will respond to the questions at the next region meeting. The ad hoc guidelines committee may also visit the MSO office in April on the Saturday before the region meeting to be able to talk with board members.

- A. Describe the nature of the relationship between MRSCNA and the MSO.
- B. What is their function? What services do they provide to the Region, and what value is added to MRSCNA for the financial investment? How may we better utilize them?
- C. Where do they exist in the current NA service structure? Do they mainly serve the Detroit region, not our region?
- D. Is it appropriate within our MRSCNA guidelines to reserve a position for the MSO representative?
- E. In what ways would it be detrimental if MRSCNA ceased to maintain an MSO Representative position?
- F. What expenses do we pay to the MSO or for the MSO rep?
- G. Why does the MSO keep asking for donations from our Region, without explanation? Who is initiating those requests and why?

Saturday before the region meeting, we went to a workshop about predatory behavior at NA meetings. The RD and RDA have suggested doing this and other issue discussion topics at the area level. They are willing to help put a workshop together or help the RCM's put one on for their areas.

In regard to the NA meeting finder app., World services is no longer posting meetings. Instead, they will be done through the web servants of local areas. This is important for meetings that don't go to area that would normally contact world or region to be put on meeting list to be searchable online. Areas need to make sure that they are putting these meetings on the local website so they can be found.

We have \$15 to return to the area because the hotel was cheaper than expected.

The regional body is requesting \$15 per meal, instead of a per diem to be used at multi day service events. This request is to help trusted servants, offset the cost of attending these events. Similar to how we currently do requests for travel reimbursement, this will be automatic for the regional administrative body, and by request for RCM's.

Co-facilitator and co-treasury are open positions.

The next MRSCNA meeting will be held via Zoom, on February 4, 2024.
