## PR South Subcommittee Report

The PR South Subcommittee is pleased to provide an update on recent activities. A regular meeting schedule and location have been established; the subcommittee meets on the last Wednesday of each month following the New Attitudes Group Meeting.

On August 27th, Bob W. and Jim C. participated in the International Overdose Awareness Day event in Manistee, organized by Centra Wellness Network. The Area PR tablecloth and literature were displayed, alongside materials from the New Attitudes group, including their key tag displays and the area meeting directories. Attendance was positive, and several members delivered open speeches during the event.

The first meeting of the South Northwestern Area PR Subcommittee took place on August 27, 2025, with four members present. Discussion focused on defining public relations within the context of the subcommittee and identifying strategic objectives. Members expressed enthusiasm about collaborating as a

group and looked forward to selecting trusted servants to further the subcommittee's goals. Outreach opportunities were discussed, specifically travelling to groups in the southern part of the Northwestern Area to promote participation and support.

Additionally, Eagle 101.5 was contacted regarding Public Service Announcements. David Hallenberg agreed to offer 15–30 second advertising spots airing daily for \$187.50 per month, with a total of 30 spots (15 purchased and 15 complimentary) scheduled over 30 days. Pending committee approval, a contract will be drafted, after which recording and broadcasting are set to commence in October.
