RCM report March 2019

Per the terms of MSO's repayment agreement with NAWS, they were required to make monthly payments and pay new invoices on Net 45 day terms. They were unable to make the full payment of \$11,900 on our December order when it came due in February. The chairperson asked NAWS to modify our agreement. Per a new agreement, the \$11,900 was added to the remaining balance. The new repayment plan for the balance of \$24,918.80 is to make nine monthly payments of \$2768.76 beginning March 1, 2019. However, they no longer have Net 45 day terms. The office must prepay for each order before NAWS will ship it. They placed an order for \$6360 on February 22.

The consultant (former office manager) and one of the office workers resigned in February. The chairperson intends to terminate the two remaining office workers at the end of March and staff the office with volunteer board members. The regional service committee expressed concerns that there is no competent person on the board or in the office. We need to get the region's stuff out of the office before they close.

Budgets/Finance

Budgets were submitted for the 6-month period ending in September. We will have annual budgets after that. RD \$890, RDA \$560, PR \$1000. We will send \$2000 to the World Service Office and reserve \$2000 to send Regional Committee Members to the MRSLD in Racine, WI. Washtenaw Area proposed we make a donation to the MSO. There was consensus against making a donation and the motion was withdrawn.

Hospital and Institution

The Women and Men of H&I are doing alright. There will be a few changes to the process involved in going into the jail.

The new process for going into the jail will now require an extra step for members to attend the PR/H&I meeting in order to pick up their badge. When someone wants to go into the jail they will first attend the jail's orientation to be cleared. Once cleared they will then be required to come to a subcommittee meeting to pick up their badge and to be given the do's and don'ts of H&I. Also, this gives the PR subcommittee the opportunity to speak with the volunteers and brief them on how to move forward. The next orientation for the Washtenaw County Jail will be held **April 13th at 9:00 a.m.** in the learning resource center.

As far as the Huron Valley Women's Prison goes, one woman in Washtenaw County has been cleared and orientated to go into the Prison. Moving forward we are going to speak to Western Wayne about alternating weeks that each area is responsible for sending women in. For example, the first, third, and fifth week of each month Washtenaw Area will be responsible for women going in from our area. Then the second and fourth week Western Wayne Area will be responsible for sending women in. The same process as the jail will be applied to Washtenaw Area women who want to go into the prison, except it is a different orientation then the jails. We will be presenting this idea to Western Wayne Area at their next H&I meeting. This way we are not taking on the commitment by ourselves but still are responsible for the volunteers in our area.

Past Month

The PR subcommittee recently purchased 3 tier IP holders to place at facilities in the community. Two of the holders had been placed in the community and this month the third was placed at Parkridge Community Center. Also, the PR committee donated 6 Basic Texts to Spera Detox Center for their clients to use while in treatment.
